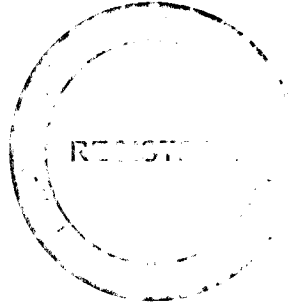



The Authority hereby grants Generation Licence to Mr. Muhammad Faraz Muslim, for 12.10 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 285768, located at Plot # 78/II, 23rd Street, Phase-VI, Defence, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
