

The Authority hereby grants Generation Licence to Mr. Naheed Salahuddin Siddiqui, for 10.07 Kw photovoltaic solar based distributed generation facility, having consumer reference number LA 647899, located at Plot # 37/2, Street # 15, Phase-V, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
