

The Authority hereby grants Generation Licence to Mr. M. 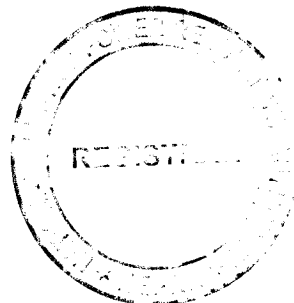
