

The Authority hereby grants Generation Licence to Syed Mazhar Hussain, for 19.80 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 183107, located at Plot # B3, Navy Housing Scheme, Phase-V, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 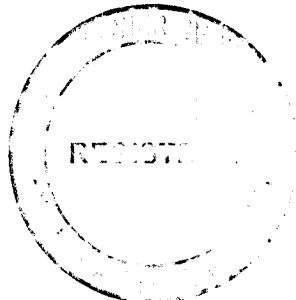
