

The Authority hereby grants Generation Licence to Mr. Muhammad Hussain, for 20.74 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 351904, located at Plot # 92/A/18, Block-5, Clifton, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 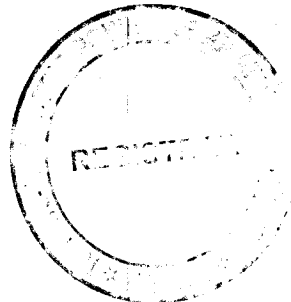
