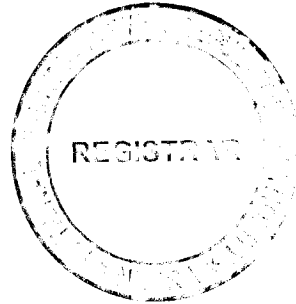



The Authority hereby grants Generation Licence to Asmat-Nisa Crystal Filling Station, for 8.625 KW photovoltaic solar based distributed generation facility, having consumer reference number BL 003341, located at Plot # 03, Block-3, Main Rashid Minhas Road, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 
