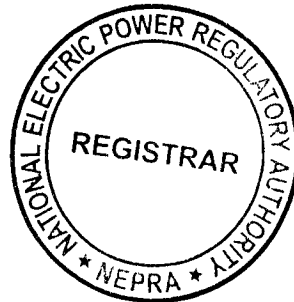



The Authority hereby grants Generation Licence to Mr. Samar Jehan Younas, for 14.62 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 839373, located at Plot # 1/4, Saba Avenue, Phase-V, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 
