

The Authority hereby grants Generation Licence to Gulshan Service Station (C.N.G), for 15.30 kW photovoltaic solar based distributed generation facility, having consumer reference number BL 002272, located at Plot # P.P.1, Block-14, Gulshan-e-Iqbal, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. This Licence is valid up to 31<sup>st</sup> day of May, 2027.
