

The Authority hereby grants Generation Licence to M/s U. M. 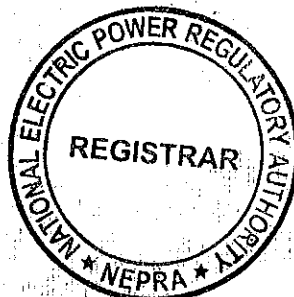
