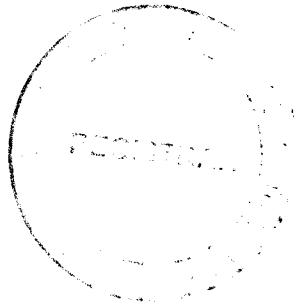

The Authority hereby grants Generation Licence to Mrs. Saira Strobel, for 8.75 kW photovoltaic solar based distributed generation facility, having consumer reference number LB 029759, located at Plot # 5/2, Zufiqar, Street # 7, Phase-VIII, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. This Licence is valid up to 31<sup>st</sup> day of March, 2027.
