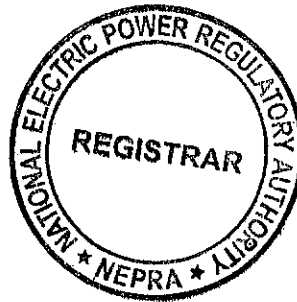



The Authority hereby grants Generation Licence to Mr. Naeem Ikhlas, for 11.73 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 839319, located at Plot # 127/2, Khayaban-e-Badar, Phase-VI, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 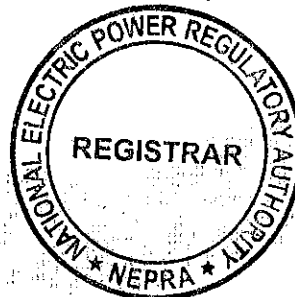
