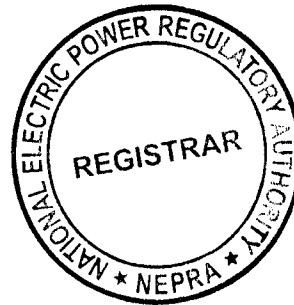

The Authority hereby grants Generation Licence to Mrs. Fauzia Hanif, for 14.0 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 253964, located at 120/II, 9th Street, Phase-VI, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
