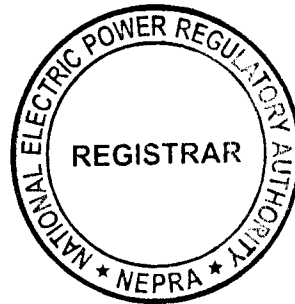

The Authority hereby grants Generation Licence to Mr. Usman Naseem, for 30.36 KW photovoltaic solar based distributed generation facility, having consumer reference number BL 000983, located at Plot # 2-C, 12 Comm Street, Phase-II Ext, DCHS, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 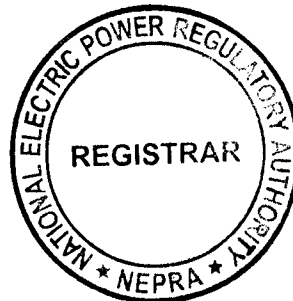
