The Authority hereby grants Generation Licence to Mr. Muhammad Abdul Samie Cashmiri, for 13.11 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 303658, located at Plot # 227-A, 28th Street, Khayaban-e-Iqbal, Phase-VIII, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
