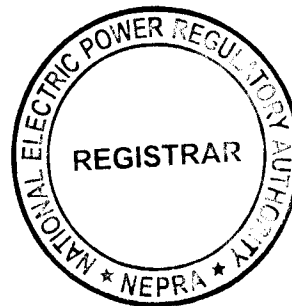



The Authority hereby grants Generation Licence to Sheikh Tariq Jamil, for 5.28 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 395516, located at Plot # 22/1, Street # 28, Phase-V, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
