The Authority hereby grants Generation Licence to Mr. Kashif Hisam, for 10.375 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 169713, located at Plot # D-83, KDA Scheme-1, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. This Licence is valid up to 21<sup>st</sup> day of April 2027.
