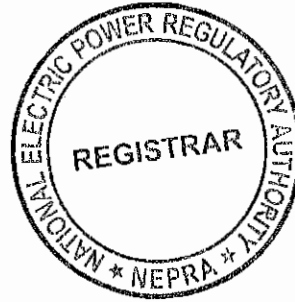



The Authority hereby grants Generation Licence to Mr. Muhammad Afaq Saeed, for 20.01 KW photovoltaic solar based distributed generation facility, having consumer reference number LB-293270, located at IH-57, Chota Malir Scheme - 33, Gulistan Johar, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
