

The Authority hereby grants Generation Licence to Mrs. Sheeba, for 23.76 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 333789, located at Plot # SC-49, AFOHS, Faisal Falcon House, PAF HS PECHS, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
