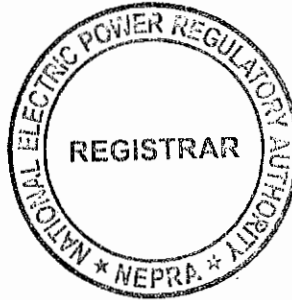



The Authority hereby grants Generation Licence to Mrs. Humaira Nadeem, for 14.145 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 278593, located at Plot # 85, Khayaban-e-Ghazi, Phase-VI, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
