

The Authority hereby grants Generation Licence to Mr. Muhammad Farrukh, for 6.60 KW photovoltaic solar based distributed generation facility, having consumer reference number AM 148346, located at House # 35/11, Survey Sheet # 35-P/1, Block-7 & 8, C P & Behar Co-Operative Housing Society, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
