The Authority hereby grants Generation Licence to Ms. Tasneem Khalid, for 12.0 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 133731, located at Plot # 16-B, South Sea View Avenue, Phase-II, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 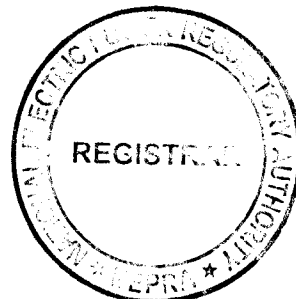
