

The Authority hereby grants Generation Licence to Mr. Qumail Habib, for 19.20 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 754955, located at Plot # 15/1, Khayaban-e-Momin, Phase-VI, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. This Licence is valid up to 5<sup>th</sup> day of May 2027.
