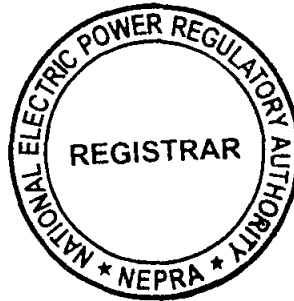




The Authority hereby grants Generation Licence to Farooq E Azam Masjid, for 10.56 KW photovoltaic solar based distributed generation facility, having consumer reference number AM 116478, located at Farooq E Azam Masjid, Block 7, F.B. Area, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
