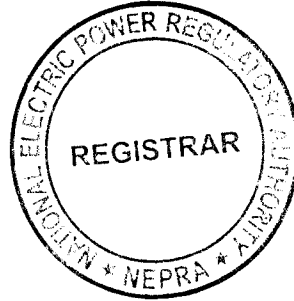



The Authority hereby grants Generation Licence to Sadiq Gasoline, for 22.10 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 226921, located at Plot Street-1A, Block-14, Dastagir, F.B Area, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
