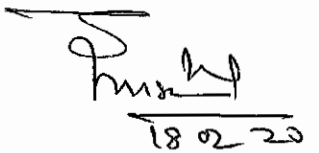

The Authority hereby grants Generation Licence to Mstt. 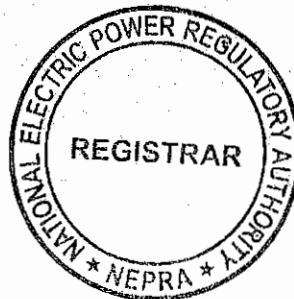
