

The Authority hereby grants Generation Licence to Mr. Shabbir Ali Allibhi, for 10.23 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 055062, located at Plot # 145/Q/2, P E C H S, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. This Licence is valid up to 17<sup>th</sup> day of Feb. 2027.

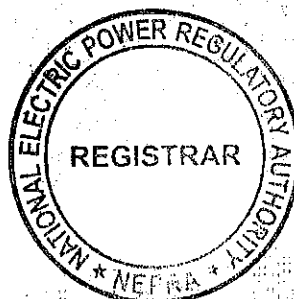
