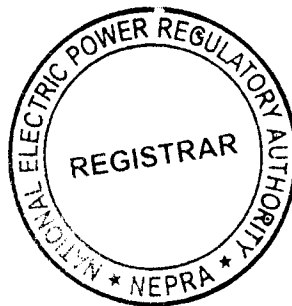



The Authority hereby grants Generation Licence to Mr. Muhammad Ilyas, for 4.96 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 877953, located at Plot # D-54, KDA Scheme-1, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 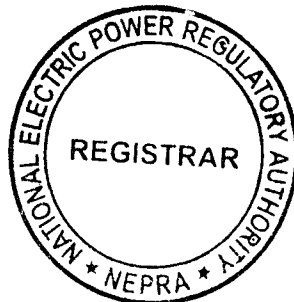
