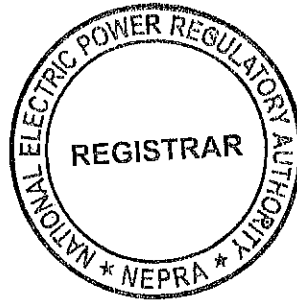



The Authority hereby grants Generation Licence to Mr. Abdul Raheem, for 20.46 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 286102, located at Plot # 114/1, 10th Street, Phase-VI, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
