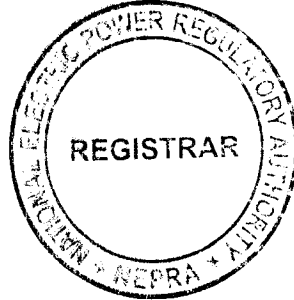

The Authority hereby grants Generation Licence to Mr. Danish Iqbal, for 12.64 KW photovoltaic solar based distributed generation facility, having consumer reference number AM 101760, located at Plot # B-70, KDA Scheme # 01, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 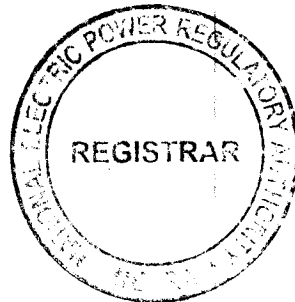
