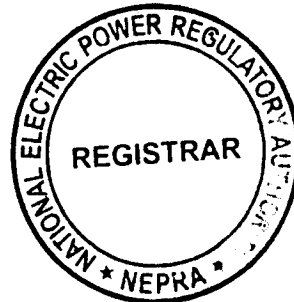



The Authority hereby grants Generation Licence to Mr. Hamid Ahmad, for 15.81 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 719247, located at Plot # A-13/A, Sunset Boulevard, Phase-II, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 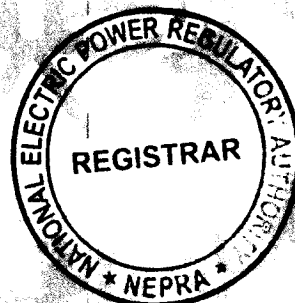
