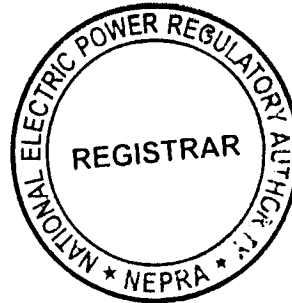

The Authority hereby grants Generation Licence to Mr. Wajihuddin Siddiqui, for 10.075 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 939161, located at Plot # 8-A, Khayaban-e-Janbaz, Phase-V, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 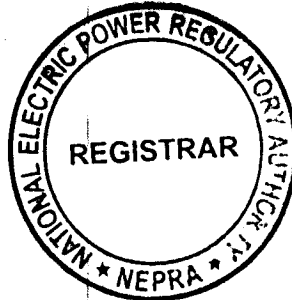
