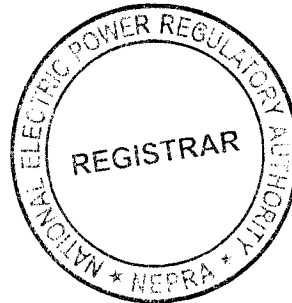



The Authority hereby grants Generation Licence to Mr. Salim Habib Godil, for 10.01 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 825142, located at Plot # 73, Khayaban-e-Hilal, Phase-VI, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
