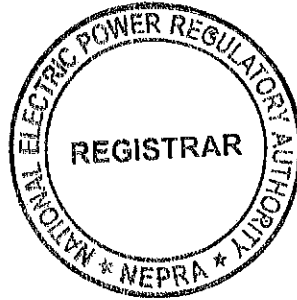



The Authority hereby grants Generation Licence to Mr. Muhammad Kashif, for 9.90 KW photovoltaic solar based distributed generation facility, having consumer reference number AM 045313, located at Plot # 58/II, 16th Lane, Phase-VII, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
