The Authority hereby grants Generation Licence to Mr. Najam Feroz Mahmudi, for 5.12 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 188743, located at Plot # 48, Central, Lane 1, Phase-II, DHA, Karachi, under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 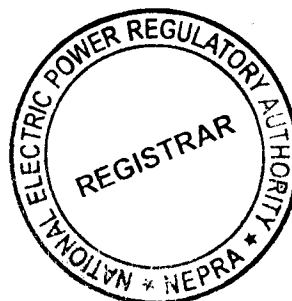
