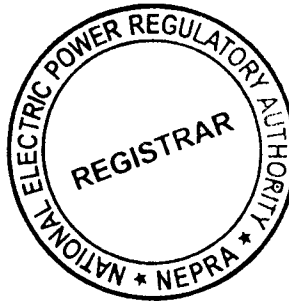

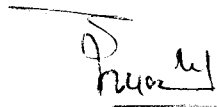

The Authority hereby grants Generation Licence to Mr. Sajid Rafiq, for 20.0 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 154390, located at Plot # 23-B/II, South Circular Avenue, Phase-II, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
