The Authority hereby grants Generation Licence to Mr. Muhammad Ali Rashid, for 20.0 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 088981, located at Plot # 45, Khayaban-e-Ettihad, Phase-VI, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
