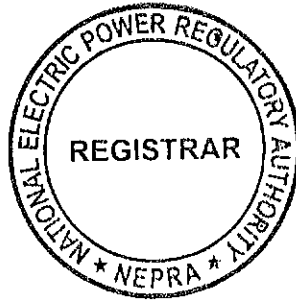



The Authority hereby grants Generation Licence to Mrs. Seema Toufiq, for 10.23 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 413962, located at Plot # D-74, Navy Housing Scheme, Phase-V, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
