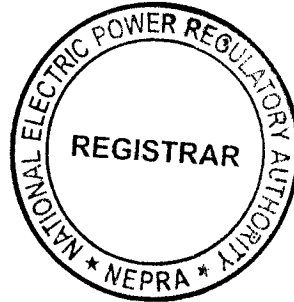



The Authority hereby grants Generation Licence to Mr. Muhammad Khalid, for 20.40 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 227487, located at Plot # C-287, Block-1, Scheme-36, Gulistan-e-Johar, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
