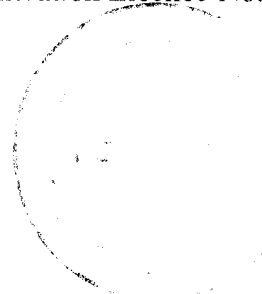



The Authority hereby grants Generation Licence to Mr. Abdul Karim Qureshi, for 10.005 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 312309, located at 98/1/1, 13th Lane, Phase-VII, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
