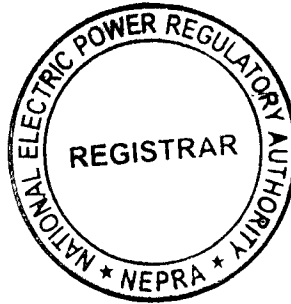



The Authority hereby grants Generation Licence to Mrs. Dureshwar, for 14.145 kW photovoltaic solar based distributed generation facility, having consumer reference number AL 654333, located at Plot # 27/1, Street-M, Phase-IV, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 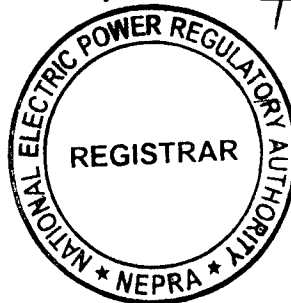
