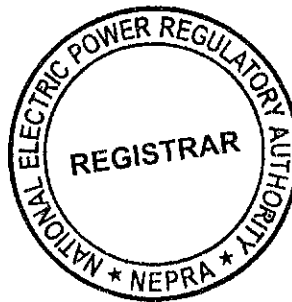

The Authority hereby grants Generation Licence to Mrs. Durreshewar Salim, for 25.53 kW photovoltaic solar based distributed generation facility, having consumer reference number AM 012764, located at Plot # 87, Khayaban-e-Ghalib, Phase-VIII-B, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
