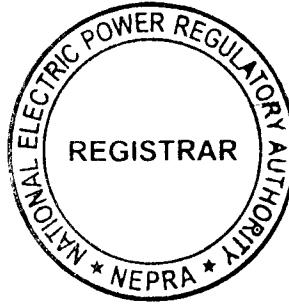

The Authority hereby grants Generation Licence to Mr. Navid Rashid, for 13.77 kW photovoltaic solar based distributed generation facility, having consumer reference number AM 128658, located at House # SC-111, SR # 5-A, AFOHS, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 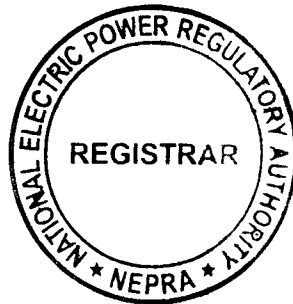
