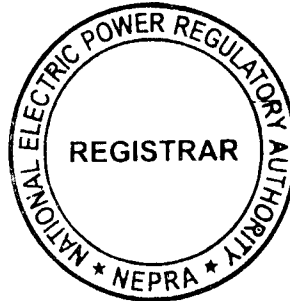

The Authority hereby grants Generation Licence to Mr. Muhammad Nasir Khan, for 6.03 kW photovoltaic solar based distributed generation facility, having consumer reference number LB 293165, located at 15/A, Latifi Society, Block-20, Gulistan-e-Johar, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 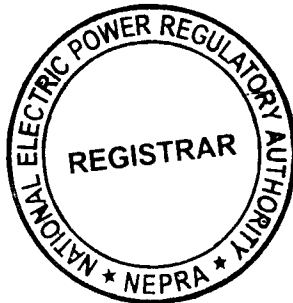
