GENERATION LICENCE

The Authority hereby grants Generation Licence to Mr. Asif Salim, for 25.875 kW photovoltaic solar based distributed generation facility, having consumer reference number BL 007111, located at Plot # 03, Khayaban-e-Sehar, Phase-VI, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
