

The Authority hereby grants Generation Licence to Mrs. Reema Ismail Ahmed, for 18.48 kW photovoltaic solar based distributed generation facility, having consumer reference number BL 005846, located at C-26, KDA Scheme-1, PECHS, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. This Licence is valid up to 12<sup>th</sup> day of March 2027.
