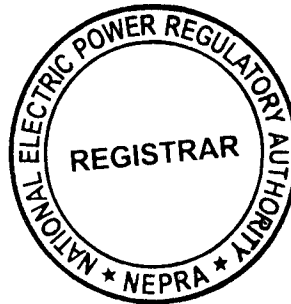

The Authority hereby grants Generation Licence to Rana Imran Safdar, for 11.88 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 369165, located at Plot # 172, Phase-VIII-A, Khayaban-e-Shaheen, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 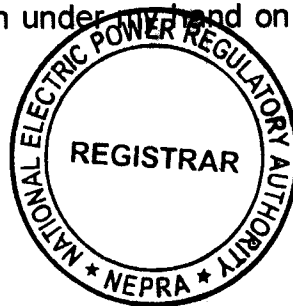
