

The Authority hereby grants Generation Licence to Habib Bank Ltd, Qasimabad Branch, for 10.005 KW photovoltaic solar based distributed generation facility, having consumer reference number AL-195811, located at Plot # 313-314-315, B Road, Liaquat Abad, Karachi, under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
