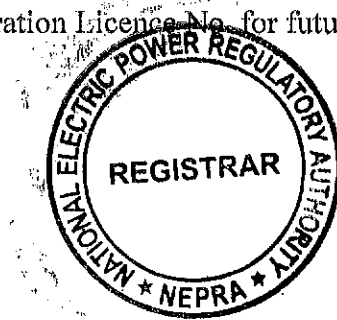



The Authority hereby grants Generation Licence to Mr. Khatri Muhammad Iqbal, for 9.60 KW photovoltaic solar based distributed generation facility, having consumer reference number AP 051217, located at Plot 15/A, Block 7+8, B Y J C H S, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
