

The Authority hereby grants Generation Licence to Mr. Sabah Uz Zaman, for 10.005 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 160238, located at Plot # 93/1, Lane 15, Phase-VII, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
