

The Authority hereby grants Generation Licence to Mr. Khurram Khan, for 10.20 KW photovoltaic solar based distributed generation facility, having consumer reference number BL 004589, located at Plot # 153/II, Commercial Avenue, Phase VII, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
